



MEMORANDUM OF UNDERSTANDING

BETWEEN

GO STUDY GLOBAL EDUCATION GROUPS (PRC) CO., LI MITED, CHINA (GO STUDY)

AND

UNIVERSITAS NGUDI WALUYO

1. Parties

Recognizing the benefits from the establishment of international links, this Memorandum of Understanding (MoU) is made and entered into by and between GO STUDY GLOBAL EDUCATION GROUPS (PRC) CO., LIMITED, CHINA, hereinafter referred to as "GO STUDY", and the Universitas Ngudi Waluyo, hereinafter referred to as "UNW".

2. Purpose

The purpose of this MoU is to establish collaborative undertakings and use domestic and overseas resources of both Parties to carry out the relevant cooperation in international cultural collaboration. Both GO STUDY, together with its institutional partners in China, and Indonesia wish to pursue a collaborative relationship to the greatest extent possible through the following collaborative activities.

- 2.1 Exchange of student
- 2.2 Academic exchange activities between faculties and researchers
- 2.3 Organizing courses, seminars and workshops
- 2.4 Promoting other collaborations as mutually agreed

3. Term of MoU

The agreement shall take effect upon approval by both institutions and shall remain in effect for an initial period of five(5) years. Thereafter it shall be automatically renewed from year to year; however, after the initial period either institution may terminate the agreement at the end of a given year by providing six(6) months' notice in writing off such intent. Termination of the agreement will not affect any project so that they may complete the agreed-upon duration of their participation.

4. General Provisions

4.1 Amendments

Either Party may request changes to this MoU. Any changes, modifications, revisions or amendments to this MoU which are mutually agreed upon by and between the Parties to this MoU shall be incorporated by written instrument at least three months prior to the execution, and effective when executed and signed by all Parties to this MoU.

4.2 Confidentiality

Each Party shall undertake the confidentiality for the mode of cooperation, all relevant document and materials of this Agreement and the supplementary agreement, annex, only used for the performance of this Agreement. These shall not be disclosed to any other party other than the Parties of this Agreement without the written permit of other Parties.
